Dear Chairman Leahy, Chairwoman DeLauro, Vice Chair Shelby, and Ranking Member Granger,

The undersigned members of the Friends of the National Institute of Environmental Health Sciences (NIEHS) write to urge the prompt passage of the fiscal year (FY) 2022 appropriations bills with increases for public health programs including the National Institutes of Health (NIH) and the NIEHS. We encourage Congress to move forward in good faith negotiations and to provide at least \$46.1 billion for the NIH. As part of our overall recommendation for the NIH, we ask you to provide at least **\$888.7 million for the NIEHS in FY2022**.

We are concerned that a full-year continuing resolution (CR) would further disrupt the biomedical research enterprise, including the unique research led by the NIEHS. Due to the uncertainty of a CR, the NIEHS is unable to fully commit anticipated resources to multi-year grants, resulting in delays in funding for extremely competitive grants and high-impact new projects.

Support for NIEHS's research programs have increased importance with the public health challenges of the COVID-19 pandemic and a more complex set of environmental exposures that influence the progression of diseases, including, but not limited to, cancer, autism, asthma, Parkinson's disease, autoimmune diseases, chemical intolerance or toxicant-induced loss of tolerance, and chemical sensitivities in adults and children.

The NIEHS is poised to generate many exciting new discoveries about the impact of environmental factors, including climate change, on human health. The member organizations of the Friends of NIEHS look forward to your acknowledging the importance of biomedical research to the nation's public health infrastructure by providing at least **\$888.7 million for the NIEHS in FY2022**.
